1. The certified organisation shall only claim that it's Food Safety Management System has been certified when it is in the possession of a valid certificate of conformity issued by the NSI Certification Body (CB) bearing the FSSC 22000 logo for the specific scope of certification.
2. The FSSC 22000 logo may be used on the organization's printed matter, website and other promotional material subject to the following design specifications:

3. Use of the logo in black and white is permitted when all other text and images are in black and white.
4. To avoid the impression that the CB has certified or approved any product, process or service supplied by the certified organisation the FSSC 2200 logo is not allowed to be used on:
 - a) a product or *product package;
 - b) its labelling;
 - c) its packaging;
 - d) in any other manner that implies FSSC 22000 approves a product, process or service.
5. The certified organisation shall ensure that the FSSC 22000 logo shall not be used by its clients for promotional or publicity purposes.

**Product package is considered as that which can be removed without the product disintegrating or product being damaged.*

6. Upon withdrawal of the certificate of conformity, however determined, the organisation shall discontinue the use of the FSSC 22000 logo or reference thereto, return the certificate of conformity to the CB immediately, and withdraw all advertising matter which contains any reference thereto.
7. The condition for the use of the FSSC 22000 logo shall be contained in the Certification Contractual Agreement to be signed by both parties (CB and certified organisation) and shall be binding.
8. This document shall be uploaded onto the NSI website and each certified client shall be provided with a copy of this document.
